Exhibition of the Wax Ships



The ships are made in the form of a candle, and as
such, are unique in the world. The idea came from a
desire for something special and unusual. The artist
wanted to connect extinct traditional crafts, history,
culture, and a love of art and the sea. These wax model
ships were first created in April 2005.

KARAKA - Dubrovnik's merchant sailing ship.

The type of sailing ship called the carack
("karaka" in Croatian) was built in Dubrovnik
shipyards from the 15th to the beginning of
the 17th century, and at the time they were

among the largest merchant ships in the world.
Caracks mainly transported costly cargo so
they had weapons, up to 40 cannons, to fend
off pirates. Crews were up to 140 people. The
main mast carried a banner with the image of
Dubrovnik's patron St. Blaise.

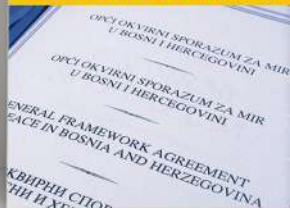

Vor allem im Bereich der neuen geistlichen Musik und der Suche nach einer zeitgemäßen Sprache für die Rede von Gott inspirierte er viele, besonders im Rahmen der Jugendarbeit (z.B. KSD), auf Katholikentage und Kirchentagen. So wählte er von Dörschke und Bortolus, aber auch von Rem und Brünel aus, Seine besondere Nähe zu Ländern Mittel- und Südosteuropas (Polen, Litauen, Kroatien) machte ihn zu einem gefragten Gesprächspartner auf europäischen Foren, auch in politischen und kulturellen Fragen. Anlässlich des 80. Geburtstages sind in diesem Sammelband alle wichtigen Texte (Mediationen, Gelübde, Gebete und Lieder) des Autors zusammengetragen.

Dominikanaec Dietrich Zils je svjetski Europejancin koji je upoznao i promicao i pomoću kulture i narode tijekom svojih boravaka u Hrvatskoj, Bosni Hercegovini, Poljskoj, Latviji i Belgiji pa je stao postao i vrlo važan partner u razgovorima na europskoj pozornosti na suvremenu katolika, kršćana i vjerska episkopata. Dječakao je u Njemačkoj u Dörschke i Bortolus, zatim u Rimu, Zürich i Bruxellesu i danas živi u Marburgu. Povodom 80. obljetnice knjige su obilježili važnih teksta (meditacija, molitve i pjesme) na nekoliko europskih jezika, među ostalim i na hrvatskom jeziku.

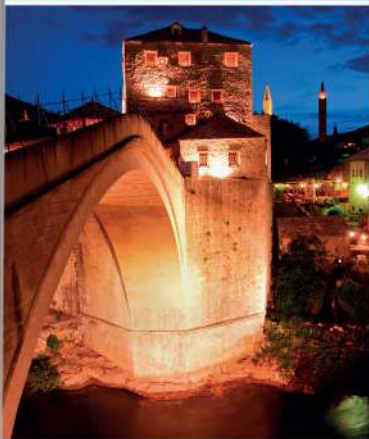

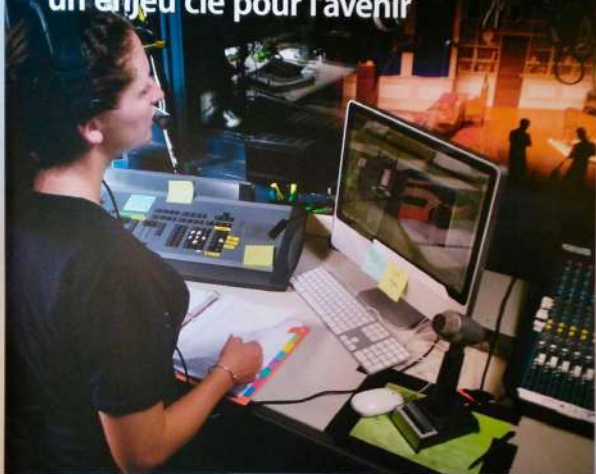
